### **Section 8 Inspection – What to Expect**

- The lead will start with a lengthy, detailed conversation with school leaders to agree KLEs based on the schools knowledge of its strengths and weakness
- The inspection timetable will then be bespoke
- The SEF is a key document but they will NOT ask for it.
- Leadership, safeguarding (PREVENT, Equality, Gangs), reading and school ethos (British Values) are Golden Threads
- HMI may ask to meet with pupils, parents and will speak to governors
- Key focus for governance is knowledge of school including its strengths and weaknesses, impact of pupil premium / sports funding, strategic skills (not procedural), support and challenge for headteacher, and safeguarding.
- HMI will gather first hand experience in lessons and around the school based on the KLEs





#### Section 8 - ADVICE

#### Good schools are not perfect schools

The Lead will be checking:

- If the school knows its weaknesses
- If there is a plan in place to address them
- If the actions are having an impact

Governors must be able to say how they are checking that improvements are being made on key weaknesses.





#### **Section 8 – Identify, Action and Review**

Weakness	Action	Impact (6 weekly)
Girls in phonics	Small group support Tailored multi sensory approach Sharp tracking every fortnight to adapt teaching / groups	98% making expected progress 30% rapid Phonemes learnt and retained. Gap closing rapidly for 10 girls (moved up a group)





#### Why Convert to a Section 5 Inspection?

The lead may decide to convert to Section 5 Inspection because:

- They need further evidence to be convinced that the school remains good
- They have concerns which need further investigation in order to be satisfied that the school remains good.
- The school may be better than good and a more thorough inspection is required in order to ascertain if this is the case.

ANY OUTCOME IS POSSIBLE ON CONVERSION





# **Conversion to Section 5 What Happens Next?**

Section 8 has been carried out by a HMI

Section 8 has been carried out by an Ofsted Inspection trained to also carry out Section 5 Inspections.

Section 8 carried out by an Ofsted Inspector not trained to carry out Section 5 Inspections

- Usually the next day
- Same lead inspector joined by a team of Ofsted Inspectors:eg.
   1 form: lead + 2 Ols
- No inspection the next day (Lead hands over to HMI)
- Two day inspection with a new HMI
- New team (old lead not on the inspection)





### **Outcomes - A Big Focus On...**

- Wider curriculum
- High outcomes in English and maths at the expense of other subjects
- More Able attainment and progress across the curriculum (breadth) – especially disadvantaged pupils
- Reading (higher and lower attainers)





#### Outcomes – Consider....

- How can you demonstrate strong progress across other subjects?
- Collate what you want the inspection team to see
- Ensure your in school assessment information tells the story
- Have case studies for DA pupils (including those with high prior attainment)
- Do you have a clear rationale for PP expenditure across the range of groups (SEND, More Able etc.)





### **Leadership and Management**

- The impact of leaders is the main thrust of the inspection and a Golden Thread
- Ofsted will test the schools ability to evaluate itself accurately
- No set practice is expected
- Continued focus on breadth and balance of the curriculum
- Policies must match practice
- Management of attendance a key area
- Inspectors will collect information about the processes which keep governors informed of practice and enable them to challenge leaders effectively





# Behaviour, Personal Development and Welfare

- Each aspect has a separate judgement. The lowest judgement will be the overarching judgement
- Expect a focus on school ethos: 'What is it like to be a pupil in your school?'
- Where there is challenging behaviour, schools will be asked to demonstrate how they have improved it (e.g. case studies, exclusion records etc.)
- There will be a focus on attendance if it is below national





### Teaching, Learning and Assessment

- LIMITING JUDGEMENT
- No judgement for a lesson observation on its own
- Expect lots of work scrutiny alongside pupils
- There are no set expectations regarding quantity or frequency of work in books and evidence folders
- Expect exploration into what the school says it does and what actually happens on a daily basis: eg. daily phonics
- Inspectors will test out leaders judgements of the quality of teaching and learning (e.g. joint observations, a particular type of teacher etc.)
- AfL behaviour and its impact on progress is still important
- How do governors know about the quality of teaching, learning and assessment?





## Promotion of British Values, Gangs and Tackling Extremism

- All are Golden Threads
- Ethos should promote British Values at its core
- How do you protect children from extremism and radicalisation in school and in the community?
- Governor Services Training on the Prevent Duty
- WRAP3 Training on the Prevent Duty
- More than just about staff attending training. It needs to be a more substantial awareness reflected in promotion e.g. Check the filtering facility in IT, does the IT policy mention extremism?
