


KS2 - Subject Attainment

Reading Attainment, %





- We are modelling the NFF and will report to the Schools Forum on 12 October
- **Consultation** with the SF and schools on the transitional formula keep current or full NFF or something in between

- Education Services Grant funding the council is considering whether to ask maintained schools to cover some of the cost for next year
- Total reduction in LA ESG funding £2.8m
- Agreement to de-delegate would need support of maintained school representatives on the Schools Forum – if not agreed, the LA can refer to the S of S
- Apprenticeship levy LA seeking advice but may be unable to fund this for community schools from 18-19

Governor Responsibilities in Safeguarding

The Education Act 2002 places a duty on schools to have arrangements in place to ensure that they are safeguarding and promoting the welfare of children; and follow statutory guidance. Governing Bodies must have someone who understands the requirements of the safeguarding guidance and legislation.

The safeguarding duty on the boards of maintained schools and academy trusts includes having arrangements in place to ensure that they:

•carry out their functions with a view to safeguarding and promoting the welfare of children; and

 have regard to the statutory guidance issued by the Secretary of State in considering what arrangements they need to make (Governance Handbook (DfE 2017))



Currently (according to Watchsted) <u>92.9%</u> of schools in Barnet are Good or Outstanding (93.2% Primary, 91.7% Secondary) which ranks Barnet 27th LA nationally (up from 30th) 20th in London (up from 22nd), above Outer London (91.3%) and National (87.9%) but below Inner London (93.9%) Barnet is ranked 47th LA for Primary and 22nd LA for Secondary Note: These figures still include Claremont, Summerside and TTA

as RI schools.

Including Nursery and Special Schools <u>95.8%</u> of schools are Good or Outstanding (with 38.7% Outstanding). Only 11 LAs have a higher percentage of Outstanding Schools than Barnet
